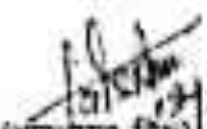

1. प्रथमिक अग्निशमन उपकरण (फायर एक्सटिंग्विशर)- भारतीय मानक धुरी के आईएसओ-2190 के अनुसार कार्यशील दशा में पाये गये जो, आईएसओआईई मार्क में निम्नलिखित हैं, एडमिनिस्ट्रेशन-8 डिस्टेंस 12 अदट फायर गैस। (1); (सर्विजिड आउटडाइंग गैस) फायर इनसुलेशन 4.5 किग्रा 01 अदट, AFFF फॉम एक्सटिंग्विशर 06 लीटर 01 अदट, डीएसोपेरी 06 डिस्टेंस 01 अदट कार्यशील दशा में पाया गया।
2. भवन में तीन स्वयंसेवा अग्निशमन उपकरण कार्यशील दशा में पाये गये।
3. फायर स्टेशन- सिविल लाइन्स इन्फ्रास्ट्रक्चर को मोड नं० 04 04944418557, 0454418559/101 मुख्य-भूतल स्थानीय पर अग्नित किया जाये।
4. एग्जिट साइनेज-सम्पूर्ण भवन में एग्जिट साइनेज स्थापित किये गये हैं।
5. वीएच सिस्टम- वीएच सिस्टम की व्यवस्था सम्पूर्ण भवन में स्थापित है।
6. निगरान मार्ग- भवन में निगरान मार्ग मानक के अनुसार स्थापित है।

अतः उपरोक्तानुसार उपलब्ध अग्नि से सुरक्षा व्यवस्थाओं के अभाव पर अग्निशमन फायर ऑडिट प्रमाण-पत्र निर्गत नहीं किया जाता है-
